IMPORTANT INFORMATION

VISA REQUIREMENT:

You will be required to have an ESTA (electronic) visa to enter the United States of America which you can apply for online at: <https://esta.cbp.dhs.gov/esta/>. To apply for this visa, you must have a valid passport, a credit card, and an email address, as well as a few minutes, to complete the online form.

TRAVEL INSURANCE:

Travel Insurance is essential. Please contact us if you have not yet got a policy in place. As a client of Holland Clarke & Beatson you will be able to take advantage of Allianz Travel Insurance. We have selected this Insurance product as we believe it to be New Zealand's leading Travel Insurance provider. For full details of the level of cover required and all terms and conditions, please request a brochure from us and read the terms and conditions carefully and do not hesitate to contact us if you need further clarification.

GRATUITIES & TIPPING:

All service charges, tips for luggage handling, and gratuities for group meals have been included in your package.

Tipping in the USA is standard practice and is a way for customers to acknowledge great service. Many employees rely on their tips as a major part of their earnings, and while leaving a tip is never 'required', it can be considered rude if you don't.

If you are exploring New York in your free time, or decide to extend your stay in the United States, you should be prepared for tipping. Tips of between 15-20% are expected for bar or restaurant service, and about the same percentage should be applied to taxi fares. Hotel staff will also appreciate a small tip for carrying your bag, hailing a cab etc. It is a good idea to carry some low denomination notes to make this easier.

EXTENDING YOUR STAY:

If you would like to extend your stay in the United States of America, any additional arrangements will be at your own cost. Prices are available upon application. Please indicate your wish to extend your stay on the Registration Form on this website, and one of our consultants will be in touch to discuss your plans.

AIRPORT TRANSFERS:

Return Airport Transfers have been included for all passengers arriving and departing on our Group Flights (arriving on 13 July & departing on 16 July). If you are not travelling on one of our Group Itineraries, you will need to make your own way to the hotel. Alternatively, we can arrange a transfer on your behalf. Prices are available upon request.

HAWAIIAN AIRLINES FLIGHT OPTION:

The flight itinerary with Hawaiian Airlines requires a stopover in Honolulu for a minimum 2 nights. Accommodation in Honolulu is not included, and hotel pricing will be available upon application. Please indicate on your Registration Form that you would like to travel with Hawaiian Airlines, and one of our consultants will be in touch to discuss your travel plans.

TERMS & CONDITIONS

1. The Promoter is European Motor Distributors Limited ("Promoter") of 1 Nixon St, Grey Lynn, Auckland 1021.
2. The 'Offer' is for the first sixty Eligible Purchasers to receive a trip for two to Formula E in New York City, 14th & 15th July 2018 valued at up to \$10,000 in accordance with these Terms and Conditions ("Travel Package").
3. The 'Offer' is:
 - a) return economy class airfares for two from Auckland to New York for departing 13 July 2018 and returning 16 July 2018, 4 to 5-star hotel accommodation in New York for 3 nights from Friday 13th July – Monday 16th July (selected by the Promoter) including a welcome breakfast on Saturday 14th July, daily breakfast, entrance for two to Formula E held in Red Hook, Brooklyn New York – 14/15 July 2018, a departure dinner at one of New York's hottest dining spots, return Airport transfers in New York for group flights arriving Friday 13 July & departing Monday 16 July and Formula E transfers in New York. Additional spending money, meals, taxes, passports, travel insurance, preferred seating, visas or travel authorisation, vaccinations, transport to and from departure point, additional transfers, items of a personal nature, in-room charges and all other ancillary costs are not included.
 - b) Depending on the location of the Eligible Purchaser's residence, the Travel Package may include return transport for two to Auckland Airport from the New Zealand city or town that the Eligible Purchaser resides in. Transport will be by economy class airfare or car. Eligibility for this to be determined by the Promoter.

Eligible Purchasers will be responsible for obtaining any authorisation to travel or visas necessary to enter the United States of America. The appropriate authorisation or visa must be gained at least 72 hours prior to the departure date. Eligible Purchasers may travel outside the above dates by arrangements with the Promoter. Any deviations from the group flights will be subject to availability at time of booking, and any additional costs associated with this will be incurred by the Eligible Purchaser.

4. The Offer opens at 8:30am on Friday 16th February 2018 and ends on the earlier of:
 - a) 5:00pm NZST Sunday 25th February 2018; or
 - b) when the 60th Eligible Purchase has been completed as required by clause 5(b) and notified to the Promoter ("Offer Period").

The Offer is deemed to be withdrawn upon the expiry of the Offer Period.

5. An 'Eligible Purchase' means the purchase of a new Audi SUV model that satisfies the following criteria:
 - a) the Audi SUV vehicle must be purchased by an Eligible Purchaser from an Authorised Audi New Zealand Dealer;
 - b) The new Audi SUV must be purchased, paid for in full and registered in the Eligible Purchaser's name during the Offer Period;
 - c) pre-orders, used vehicle purchases, demonstrator, fleet and lease company purchases are not an Eligible Purchase.

An 'Eligible Purchaser' means a New Zealand resident currently living in New Zealand that has completed an Eligible Purchase.

6. For the purpose of the Offer:

 - b) A "new Audi SUV" means any new Audi Q2, Q3, RSQ3, Q5, SQ5, Q7 and SQ7 model.

7. Customers may not use the Offer in conjunction with any other offer.
8. The Offer is made to retail customers only. It is not available to owners or employees, or family members of owners or employees of an Authorised Audi New Zealand Dealer or of the Promoter.
9. The maximum value of the Travel Package is \$10,000. The Travel Package, or any unused portion of the Travel Package, is not transferable and cannot be exchanged for alternative products or services or redeemed for cash.
10. Any credit proposed to be provided through Audi Finance is subject to its lending criteria.
11. Recipients of the Travel Package may be required to present their credit card at time of accommodation check in New York.
12. The Travel Package is subject to the standard terms and conditions of individual service providers.

13. If for any reason the recipient of the Travel Package does not use the Travel Package or any element of the Travel Package at the time stipulated, then the Travel Package or that element of the Travel Package will be forfeited and will not be redeemable for cash.
14. If the Travel Package (or part of any Travel Package) is unavailable, the Promoter, in its discretion, reserves the right to substitute the Travel Package (or part of the Travel Package) with a package to the equal value or specification.
15. A recipient of the Travel Package is deemed to have consented to the Promoter using the person's details and likeness (in the form of photographs) for promotional and media purposes without any payment or other compensation. A guest who accompanies a recipient of the Travel Package will also be deemed to have agreed to their details and likeness (in the form of photographs) being used by the Promoter for promotional and media purposes without any payment or other compensation. Any such guest will be required to sign and return a liability/publicity release on terms no more onerous than those applicable to the Eligible Purchaser prior to travel.
16. Neither the Promoter nor any other person or party associated with the Offer shall be liable for any loss or damage whatsoever suffered (including but not limited to indirect or consequential loss) or personal injury suffered or sustained in connection with the Travel Package.
17. In the event of war, terrorism, state of emergency or disaster, the Promoter reserves the right, to the extent necessary and acting reasonably, to cancel, terminate, modify or suspend the Offer or suspend or modify the Travel Package.
18. The Promoter is not responsible for any cancellations, delays, diversions or substitutions, or any act or omission whatsoever beyond the Promoter's reasonable control by the air carriers, hotels, venue operators, transportation companies, third party providers of aspects of the Travel Package or any other persons involved in providing any Travel Package-related goods, services or accommodation.
19. The Promoter's decision on all matters including eligibility, and when the Offer Period has ended, is final.
20. Any personal information collected about a person who accepts the Offer or otherwise participates in the promotion will be collected and used in accordance with the privacy principles set out in the Privacy Act 1993.
